We collaborated with **Corporation Bank – Baramati Branch and Life Insurance Corporation of India – Office of Block Development Officer - Baramati** for this program. This program was meant to create **awareness on affordable Life Insurance and Accidental Insurance for BPL community persons in Baramati**.
