1. Confirmation of the minutes of previous meeting.

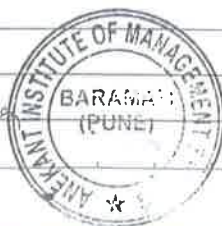
- The financial implication was discussed as below:

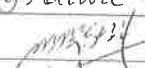
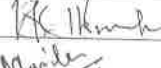
