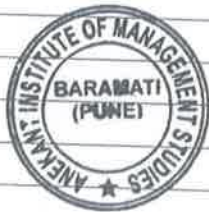

ii) To discuss and finalize the publication of the Alumni Newsletter.

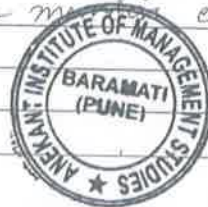
