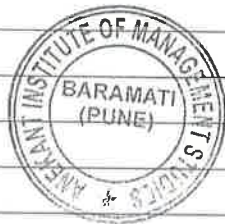
v. To discuss on our upcoming Edited Book.

With a stronger resolution to spread communication of upcoming Alumni Meet among their batchmates, the meeting was concluded.



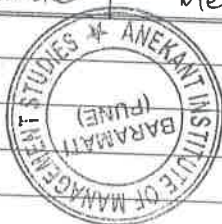

v. To discuss on Best Practices taken up during current Academic Year.

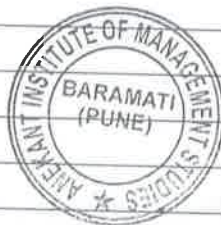

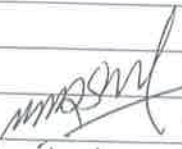
vi. To discuss on suitable date and time for next Alumni Meet
